## RECALL NEWSOM PETITION INSTRUCTIONS

Thank you for downloading our petition to Recall Governor Newsom. Below are detailed instructions for circulating and gathering signatures. Please read the instructions carefully. Also, please share the petition with your family and friends, and ask them to assist with the signature gathering.

### PETITION PRINTING INSTRUCTIONS:

- Do NOT print the petition on any size paper other than 8 ½ x 11.
- Make sure when printing, in the Print Dialog box that “Fit” or “Shrink to fit page” is NOT checked and that the “Actual Size” is checked when printing. Petitions MUST be printed at actual size only, or the petitions will be voided by the Seceretary of State.
- Do NOT print double sided. The petition was approved by the Secretary of State in a one-sided format only.

### THE DON'TS OF PETITION CIRCULATING:

- Do NOT leave petitions unattended to be signed in your absence, i.e. gunshops and other conservative places of business. The law requires that the circulator must witness all signings.
- Do NOT use E-signatures. All signatures and other info must be “wet”, i.e., original.

### HOW TO CIRCULATE:

- Each petition is county-specific. Signatures from residents of different counties must go on a county-specific petition. This is specified at the top of the petition. Ask them where they live if they agree to sign.
- Signer's name must match how they registered to vote. Their signature must also match how they signed their voter registration.
- Under the “Declaration” section at the bottom of the petition, the circulator must print their name followed by their residence address (including city, state and zip) where they are registered to vote. They do not need to reside in the same county as the signers. (section 2)
- The dates the signatures were gathered must also be stated. Month and day is sufficient as the year is already stated. (section 3)
- Upon request, you must show the signer the “Official Top Funders” sheet. (At this time, there are none to show, but please check the website regularly for any updates on the “Official Top Funders”).
- State the date you are signing the petition. Use the Month/Day/Year format.
- State the city where the signatures were gathered and finally sign and date the petition, again using the Month/Day/Year format.

## PETITION FOR STATE OFFICER RECALL

TO THE HONORABLE SECRETARY OF STATE OF CALIFORNIA,

Pursuant to the California Constitution and California election laws, we the undersigned registered and qualified electors of the County of \_\_\_\_\_, California, respectfully state that we seek the recall and removal of Gavin Newsom, holding the state office of Governor, in California.

We demand an election of a successor to that office.

The following Notice of Intent to Circulate Petition to Recall Governor Gavin Newsom was served on February 13, 2025 to Governor Gavin Newsom:

TO THE HONORABLE GAVIN NEWSOM: Pursuant to California Elections Code section 11020, the undersigned registered qualified voters of the State of California, hereby give notice, we are the proponents of a recall petition and we intend to seek your recall and removal from the office of Governor in the State of California and to demand election of a successor in that office.

The grounds for this recall are as Follows: Gavin Newsom's tenure has been marked by a series of catastrophic failures that directly impact our daily lives. His gross mismanagement during the Los Angeles County fires, with inadequate resources and delayed responses, left communities devastated. Under his watch, we've seen an unbearable rise in the cost of living - from gasoline to electricity to insurance. Crime rates have soared, with policies seemingly more lenient on offenders than on ensuring our safety.
